**Notification – Declaration of Result of Online Examination Held on 06.09.2025**

We refer to the Bank's advertisement dated 04.07.2025 and subsequent addendum/ corrigendum dated 04.07.2025 and 17.07.2025 on our Bank's website, inviting applications for Local Bank Officers (LBO) on Regular Basis in Bank of Baroda for which online examination was held on 06.09.2025.

The registration numbers of candidates who have successfully qualified in the online examination for the position of Local Bank Officer and have been provisionally shortlisted for the next stage of the selection process can be viewed by clicking on the link below:

Subsequent communication to the shortlisted candidates will be sent to their registered e-mail IDs. Please note that no communication will be sent by post.

Attention is also drawn to para number 13 of the advertisement dated 04.07.2025, inter-alia advising that the Bank reserves the right to modify the structure of the selection process, including addition or substitution of tests. Accordingly, The Bank has decided to dispense with the criteria of psychometric test, as mentioned in the advertisement, and to proceed with remaining selection process.

Candidates qualified in the online examination will now be called for a Language Proficiency Test (LPT), wherever applicable. Candidates must qualify in the LPT to be eligible for Document Verification and Personal Interview. Failure to qualify in the LPT will result in disqualification from the further selection process. Details of the LPT (schedule, venue, and other instructions) will be communicated separately to the respective candidates via their registered e-mail IDs.

Candidates who are provisionally exempted from the LPT on account of having studied the specified language of the applied State in their 10th or 12th standard will be directly called for Document Verification followed by the Personal Interview. Details will be advised separately.

It is clarified that such exemption from the LPT is purely provisional. If, at any stage of the recruitment process or even after appointment, it is found that the candidate does not possess adequate proficiency in the local language of the State applied for (i.e., ability to read, write and speak), the Bank reserves the right to take appropriate action. Such action may include requiring the candidate to undergo the LPT at a later date or cancellation of candidature/appointment, as deemed fit by the Bank.

***Important Instructions:-***

- ***As detailed in the 'Selection Procedure' section of the advertisement, candidates will be called for further selection process based on their performance in the online test. Only those who successfully complete Document Verification in terms of eligibility***

***criteria mentioned in the advertisement and produce all documents as advised, will be allowed to appear for the Personal Interview.***

- ***Detailed guidelines with respect to the Interviews for the captioned position will be shared shortly. All provisionally shortlisted candidates are advised to go through the guidelines carefully and abide by the same. Candidates are also advised to visit the Bank's website periodically for further updates/notifications.***

This notification shall be treated as intimation to all the candidates, who participated in the captioned recruitment process for the above-mentioned position and no separate communication shall be sent to all other candidates.

All care has been taken in compiling the list of candidates qualified in the online examination. However, the Bank reserves the right to rectify any inadvertent error.

The decision of the Bank in all matters pertaining to the selection process, including Document Verification, Language Proficiency Test, and Interview, shall be final and binding.
